The development and implementation of a sound and efficient legal, institutional and operational foundation for the effective functioning of the public procurement system in Bosnia and Herzegovina, in accordance with EU standards and institutional models and practices, including the use of modern information technology and e-procurement techniques is a top priority of the modernization process. The public procurement reform shall provide further transparency of public tenders whilst promoting efficiency and effectiveness in the use of public funds and reduce the potential for fraud, corruption and misappropriation.

In order to achieve the above tasks an EU-funded project has been initiated. The project aims at enhancing the public procurement legal framework with facilitating the efforts for efficiency and transparency of the public procurement in Bosnia and Herzegovina. These actions shall further improve the accountability and reliability of the sound financial management of public finance and could further enhance trust of the general public.

The project will also assist in implementation of the new Law on Public Procurement that has been adopted at the end of April 2014. The new law provides simplification, transparency and clearer rules and regulations. It also introduces the most modern tools of public procurement in line with the EU directives and lays down the foundations of the future e-procurement system.

The EU is funding this project from the Instrument for Pre-accession Assistance (IPA 2012) in the amount of 1371760 EUR. The two main beneficiaries of the project - the two pillars of the public procurement system are the Public Procurement Agency and Procurement Review Body.
