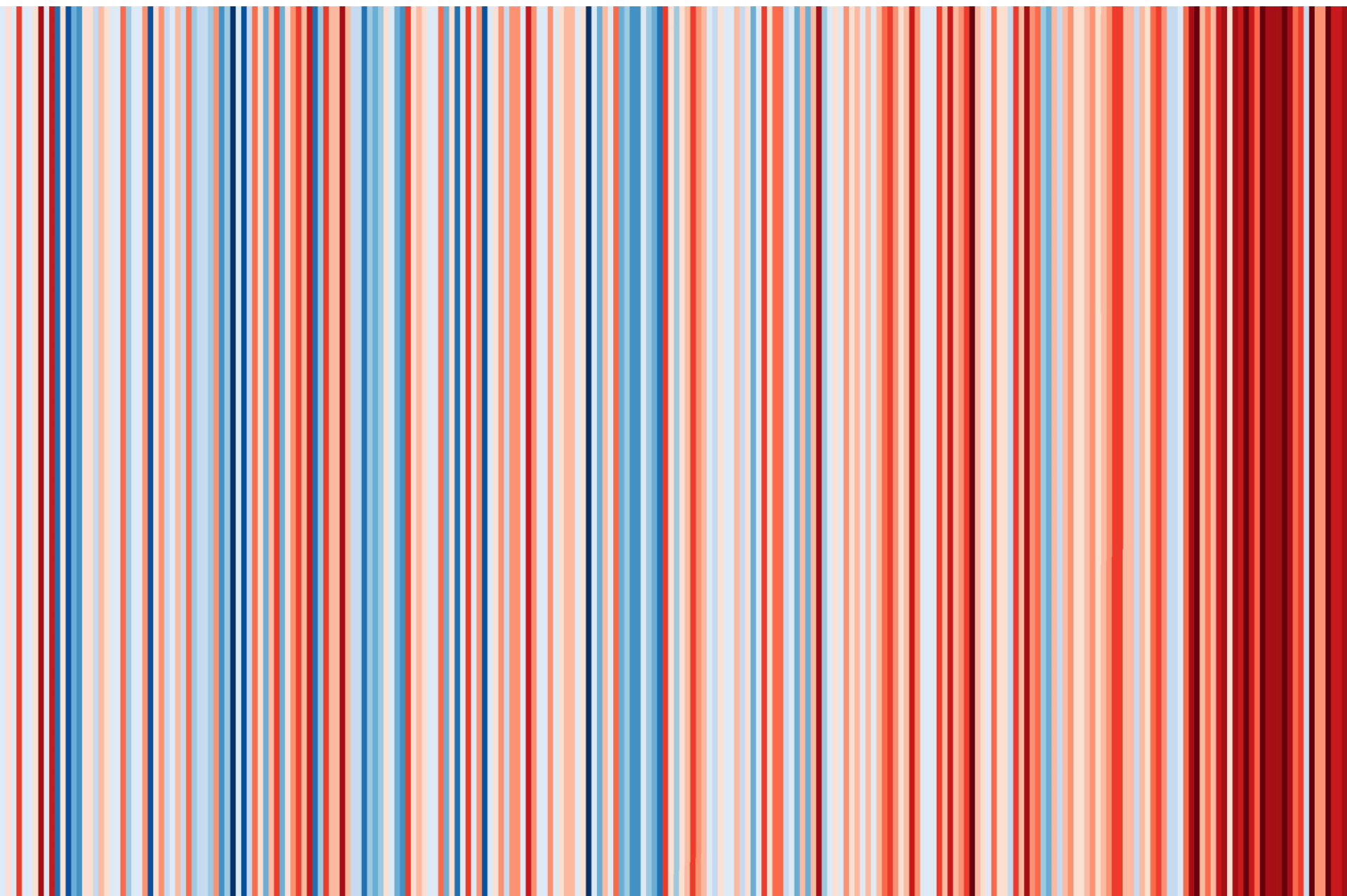

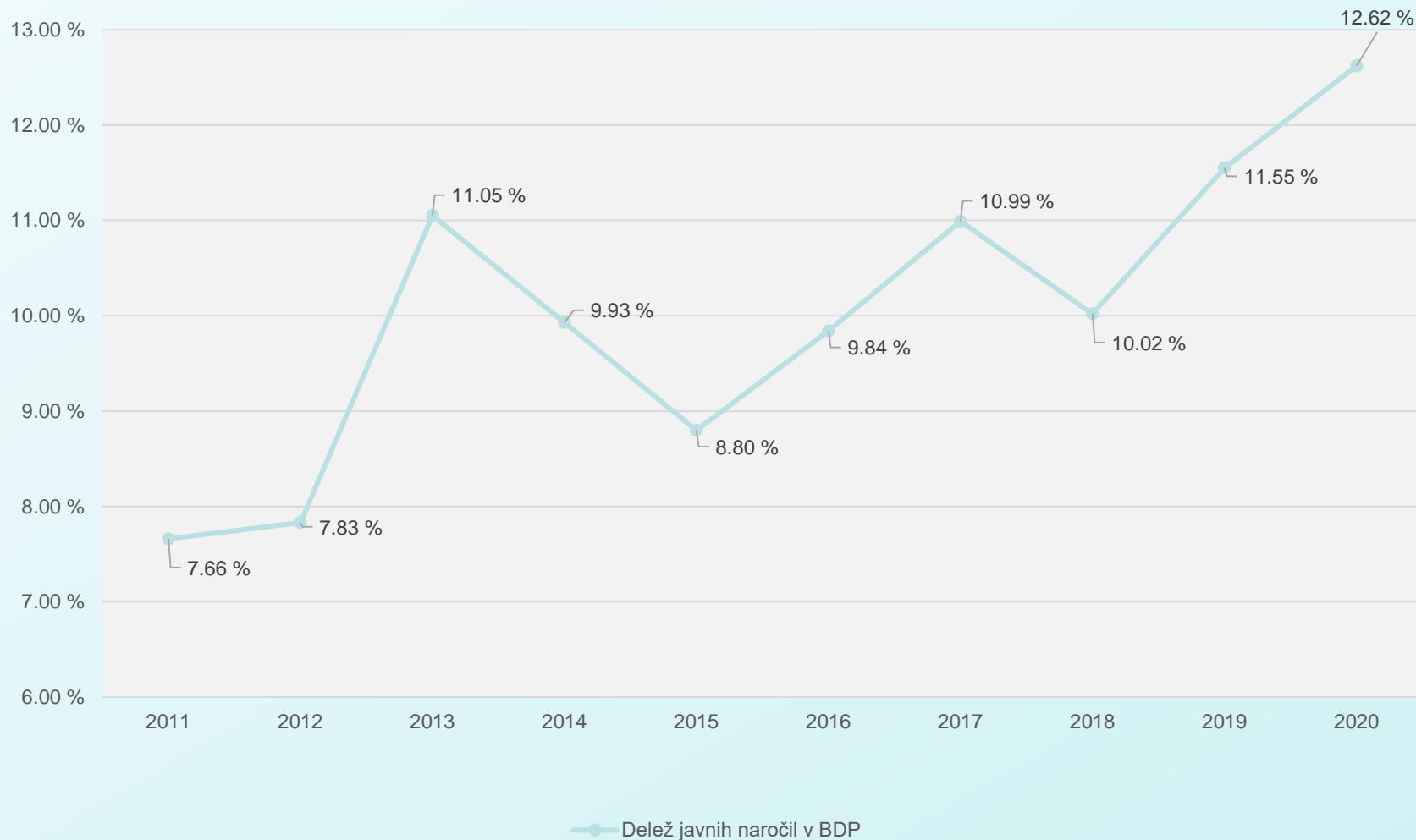

GREEN PUBLIC PROCUREMENT IN SLOVENIA

- **OBLIGATORY SINCE 2012**

- **UNTIL 2018 – 12 GREEN SUBJECT MATTERS**

electricity, food and catering services, office paper and hygienic paper products, electronic office equipment, audio and video equipment, refrigerators, freezers and their combinations, washing machines, dishwasher, dryers, vacuum cleaners and air conditioners, buildings, furniture, cleaning products, cleaning and laundry services, road vehicles, tires, electric bulbs and lamps

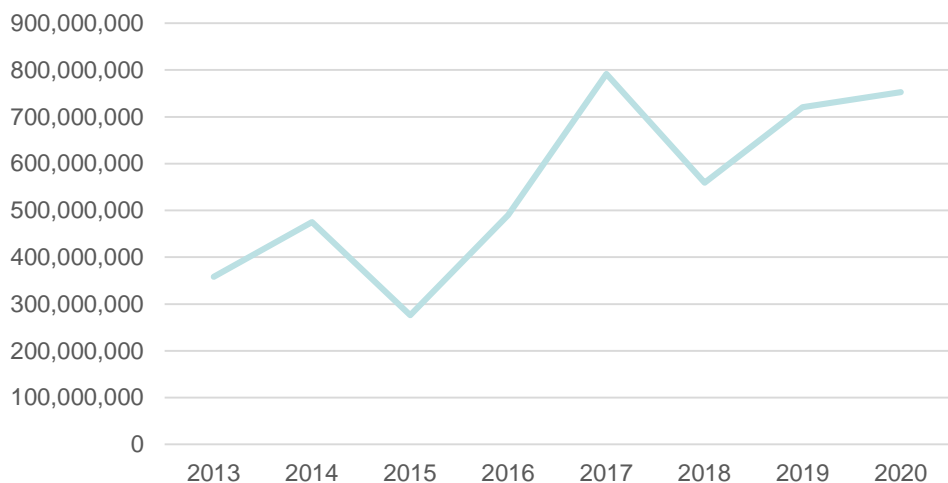
- **SINCE 2018 – 20 green subject matters + additional two since 2021 = 22 GREEN SUBJECT MATTERS**

electricity, food and catering services, **textile products**, office paper and hygienic paper products, electronic office equipment, televisions, refrigerators, freezers and their combinations, washing machines, dishwasher, dryers, vacuum cleaners and air conditioners, furniture, **water heaters, space heaters and their combinations, and hot water storage, sanitary fittings, toiletry equipment and urinal equipment, wall panels**, design or construction of buildings, **design or construction of roads**, road vehicles, tires, electric bulbs and lamps **and indoor lightning systems, road lighting and traffic signalization**, cleaning products, cleaning and laundry services, **gardening services, agricultural and other products and gardening equipment and machinery + building furniture and anti-noise road fencing**

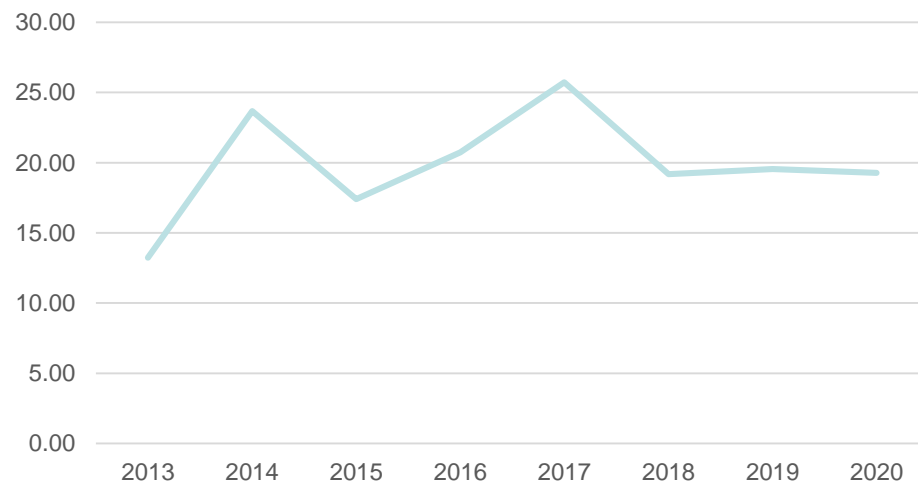

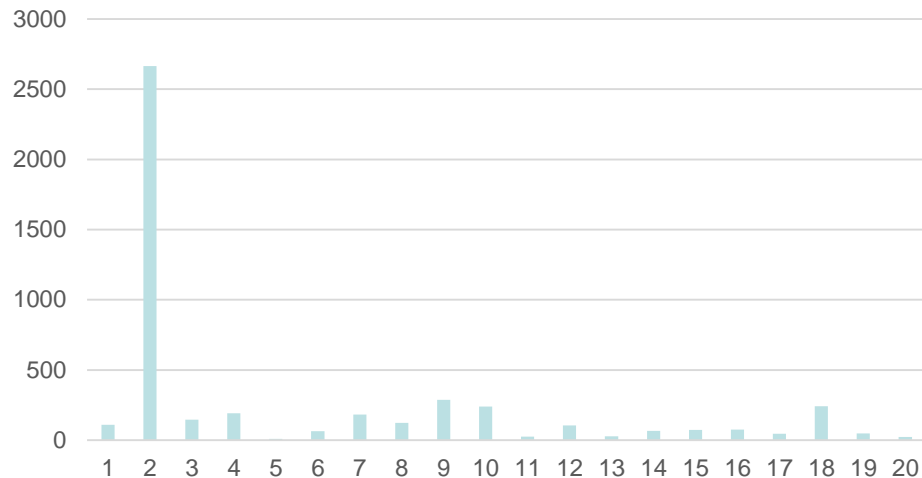

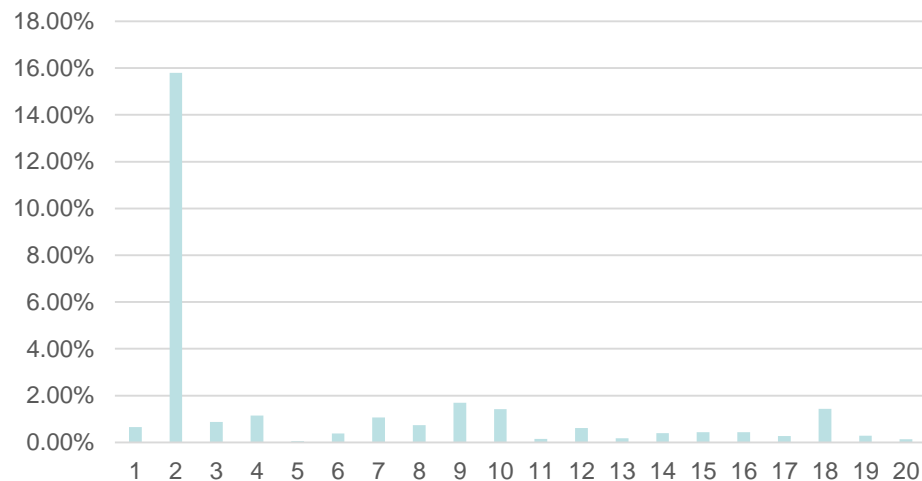

GREEN PUBLIC PROCUREMENT IN SLOVENIA

DECREE ON GREEN PUBLIC PROCUREMENT (published in the Official Gazette of the Republic of Slovenia No. 51/17, 64/19 in 121/21)

Pre-2018 (old Decree): goals and methods for each procurement group determined precisely

New decree set:

- purpose of the regulation (*to reduce negative impact on the environment with public procurement of environmentally less burdensome goods, services and works, to improve the environmental characteristics of the existing offer and to promote the development of environmental innovation and a circular economy and to provide an example to the private sector and consumers*)
- environmental aspects (*energy efficiency and the use of alternative energy sources, efficient use and re-use of water and resources, prevention of health or environmental hazards, re-use of secondary raw materials and products and prevention and reduction of waste generation, promotion of the re-use of products, repair, preparation and processing of served products and waste for reuse and recycling*)
- green public procurement goals (One or more goals are set for each of the 22 green subject matters)
- methods of integrating environmental aspects (technical specifications, exclusion ground, selection criteria, award criteria, contractual provisions)

5. Cilji iz Uredbe o zelenem javnem naročanju

Naročnik mora javno naročilo, ki vključuje predmet iz 1. točke prvega odstavka 4. člena te uredbe, oddati tako, da se v posameznem naročilu izpolni tisti cilj, ki je v nadaljevanju določen za ta predmet:

- delež električne energije, pridobljene iz obnovljivih virov oziroma soproizvodnje električne energije z visokim izkoristkom, znaša najmanj 50 %.

6. Okoljske zahteve in merila

6.1. Električna energija

6.1.1 Tehnične specifikacije	
Naročnik v tehničnih specifikacijah poleg ostalih zahtev, ki se nanašajo na predmet javnega naročila, določi:	
1.	50 % dobavljene električne energije mora biti pridobljene iz obnovljivih virov energije ¹ (v nadaljnjem besedilu: OVE) oziroma iz soproizvodnje električne energije z visokim izkoristkom (v nadaljnjem besedilu: SPTE), kot to določa zakon, ki ureja energetiko.
Način dokazovanja: Ponudnik mora k ponudbi priložiti izjavo, da bo po preteku koledarskega leta na račun naročnika unovčil ustrezno količino potrdil o izvoru električne energije, ki jih izda državni ali regionalni organ ali neodvisna organizacija, pooblaščen za izdajo teh potrdil, s čimer bo dokazal, da blago izpolnjuje zahteve. Naročnik med izvajanjem naročila preverja, ali ponudnik izpolnjuje zahteve.	
6.1.2 Merila za oddajo javnega naročila	
Za razvrstitev ponudb naročnik poleg cene ali stroškov in morebitnih drugih meril določi:	
1.	Merilo »več energije iz OVE«. Delež električne energije, proizvedene iz OVE, ki presega minimalni delež, kot ga je naročnik opredelil v opisu predmeta oziroma tehničnih specifikacijah, se v okviru meril točkuje z dodatnimi

	točkami na način, ki ga predvidi naročnik. Delež tega merila v razmerju do ostalih meril v razpisni dokumentaciji določi naročnik.
